The above details will be made available in the Commission's Website and Candidates will be informed of the above fact only through SMS and e-mail accordingly.**

If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled.
3. The candidates who have appeared for the Written Examination and whose Register Numbers are not found in the above list have not been admitted to Oral Test.
4. The admission of Differently Abled candidates to Oral Test is also provisional subject to verification and acceptance of their claim with regard to the nature and percentage of disability with reference to the orders of the Government regarding the reservation and the category of Differently Abled Persons eligible for the said post.
5. The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court,

Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

6. **Candidates who have been admitted provisionally to Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential documents will result in their non-admission to the Oral Test.**
7. The list of register numbers of candidates who were admitted to Certificate Verification and who have not been considered for provisional admission to Oral Test and the reasons therefor have been mentioned in the Annexure to this list.
